THE WAVERLY CONSORT This renowned group has supplied us with their schedule for the next six months. A majority of their 46 concerts are in New York or within a radius of 150 miles, including appearances in New Jersey, Connecticut, Pennsylvania, Massachusetts, Maryland and Rhode Island.

They will travel as far as Mexico City (11/13), Toronto (12/2), Boston (12/11), Ottawa (12/16), Pasadena (2/21), Torrance CA (2/21), Bakersfield CA (2/23), Cupertino CA (2/25) and Guelph, Canada (5/2).

All the December concerts are entitled The Christmas Story. Other performances feature Elizabethan and Baroque music of England; Medieval, Renaissance and Baroque music of Italy; the French Baroque; and in April music of the Easter season.

ACTIONS OF THE BOARD OF DIRECTORS September 25-27, 1981 was occupied with

Much of the Board of Directors' meeting deliberations about

how to restore greater order and efficiency to the New York office. Problems with the computerized mailing service employed last year (errors in entries, delays, losses of listings and materials ---including an entire issue of the Newsletter), and with some of the office help caused severe dislocations in service to members. The Board set up an office and mailing procedures committee, headed by Andrew Acs, a former office manager for ARS, to oversee office management and a new mailing service. The present office manager, Mary Ann Fleming, will work full time for the next 3 months, after which the committee will report to the Board on whether the position should become permanently full-time or revert to half-time.

One change in procedure has already been instituted: membership in ARS now begins in the quarter after the dues are received instead of being limited to the calendar or school year. Those joining through a chapter may, at the chapter's discretion, prorate the first year's membership in order to achieve a uniform termination date with the chapter.

Because of the numerous record-keeping and mailing snafus, the 1981 Directory has been so delayed that it was thought prudent to postpone issuing a Directory until early 1982, when this year's membership lists are complete.

In view of this and other problems, it was agreed that members rejoining ARS before January 1, 1982 would be charged \$12.50 rather than the \$15.00 set at the 1980 Board meeting. (Those who have already paid \$15 will receive AR for an extra quarter; those who have joined through a chapter may instead receive a rebate administered through the chapter). Although ARS will miss the lost income, it was felt by the Board that the reduction might help member and chapter relations strained by the difficulties and confusion over when the raise in dues was actually to go into effect. (Also, an error in the printing of the minutes of the 1980 Board meeting had listed the new dues as \$14.60 rather than \$15.00).

The Board raised the salary of the AR editor Sigrid Nagle to cover some of the increased time she has been spending on the magazine. It also raised advertising rates and agreed on a formula of how much advertising space would be allowed. In view of the tight financial situation, it declined to raise honoraria for articles or to pay for reviews. The Board discussed with Ms Nagle ways to make AR more representative of the Society.

Following discussion, the Board suspended for the time being the Society's involvement in music publications. After the editions currently in press at Galaxy our relationship with the publisher will be confined to marketing our previous editions. Although ARS administrative resources are directed in other areas at present, the Board recognizes the need especially to support the publication of educational and contemporary recorder music in the future.

The Education Committee is now accepting comments and suggestions on the Education Program. One person has passed the Level III exam (profile to appear in the February \underline{AR}).

The Workshop, Membership, and Chapter Relations Committees were reorganized and assigned tasks for the coming year. A new plan for backing local workshops was discussed and will be announced by Valerie Horst, Chm. Reviews of ARS workshops are planned for the next edition of this Newsletter. Chapters are encouraged to notify the editor, Fr. Hopkins, of future workshops.

CATHEDRAL, COURT AND COUNTRYSIDE

Beginning the week of October 5, National Public Radio (NPR)

s offering a 13-week series entitled Cachedral, Court and Countryside, programs highlighting the vocal and instrumental music that was part of six centuries of European life before 1700. In an age of priest and peasant, courtier and king, the series explores critical landmarks in the growth of what we now call Early Music, against the ever-changing backdrop of political, social and religious history.

Many outstanding ensembles have been engaged to provide as authentic music as possible, among them: the Deller Consort, New York Pro Musica, Pomerium Musices, the Folger Consort, Ensemble Guillaume de Machaut (Paris), the London Early MusicGroup. the NY Cornet and Sackbut Ensemble and the Boston Camerata.

Commentator is the entertaining and widely respected expert Nicholas Kenyon, music Critic for the New Yorker and former editor of England's Early Music Gazette.


