Executive Committee/Compensation/Fund

Development Review finances and state of Society monthly. Make necessary decisions between Board meetings. Oversee President's Appeal. Review performances of and compensations for editor and executive director. Plan fund-raising campaigns. Advise on ARS fund investments.

Chapters & Consorts Award chapter grants Communicate with chapter representatives. Establish inter-chapter communication and program sharing. Encourage chapters to host Board meetings to foster further input. Assist in the formation of new chapters and consorts. Provide handbooks to potential and existing chapters. Contribute to ARS resources as possible, especially the *Consort Handbook*. Evaluate and revise periodically services extended to chapters and consorts.

Éducation Supervise administration and evaluation of examinations. Award Teachers Certification. Revise Education Program publications periodically. Aid in development of *Consort Handbook*.

Junior Recorder Society Communicate with teachers and Club leaders. Devise means to market JRS. Suggest items for newsletters (student and leader). Revise and expand programs periodically.

Publications Edit and publish ARS musical editions (Members' Library). Oversee editorial aspects of magazine and newsletter. Coordinate work on *Consort Handbook*. Supervise preparation and periodic revisions of various other publications.

Scholarship Evaluate and award weekend and summer workshop scholarships.

Special Events and Professional Outreach Propose and publicize grants, commissions, residencies, and other professional programs. Plan ARS activities at festivals (in conjunction with local Task Forces). Oversee the ARS CD Club. Seek and evaluate nominations of individuals for Distinguished Achievement Award.

2000 Berkeley Festival Task Force and 2001 Boston Festival Task Force Plan and execute ARS events at summer festivals.

Seniors Task Force Find ways for senior citizens, both beginners and more experienced, to participate in recorder activities.

Fundraising Task Force Plan and execute a threeyear fundraising campaign to replenish Capital Fund and/or Katz Fund.

Special Membership Representatives Communicate with special constituencies. Stimulate their support of the ARS. Work with them on special projects periodically.

ARS/AOSA Joint Advisory Task Force Explore ways to communicate and share programs that will benefit both organizations. Members: Presidents of ARS and AOSA; three others who are members of both ARS and AOSA.

2000 BOARD ELECTION UPDATE

The Nominating Task Force, led by chair Nancy VanBrundt, is at work assembling the preliminary slate of candidates to appear on ballot to elect new Board members in May. In February, those who submitted nomination forms will be notified of their status.

Individuals not selected through the nominating process may run for the ARS Board by direct petition. ARS members in good standing may be placed on the ballot by sending the following materials to the Task Force chair before March 29: 1) A petition signed by at least 25 members of the Society; 2) A statement of the nominee's qualifications for the post of Director; 3) A statement, signed by the nominee, expressing willingness to assume Board of Director responsibilities and to serve as an ARS Director if elected. Forms to be used for the petition may be requested from the ARS office beginning in February.

MARCH IS THE TIME TO CELEBRATE PLAY-THE-RECORDER MONTH!

If the possibility of a millennial meltdown caused you to hold off planning events for this March's eighth annual celebration of Play-the-Recorder Month, there's still time! Since 1993, chapters and consorts affiliated with the American Recorder Society have staged public events of all kinds to interest the general public in the recorder and to generate new members for their organizations and for the ARS.

Chapter and consort leaders received a P-t-RM publicity packet in December containing materials and check-lists to use in drawing media attention to events. The packet is available by contacting the ARS office. Please let the office know about your events, whether large or small, so that we can include them in coverage of the overall event. Prizes, donated by ARS business members, are awarded to chapters with the most innovative projects and to those whose membership increased by the largest percentage.

DIRECTOR'S CORNER

The latest word about volunteering is good. Compared with figures from 12 years of biennial reporting, the 1999 study results by Independent Sector show the highest-ever recorded level of volunteering in the U.S. They show an increase of 13.7% over the 1995 survey figures. An estimated 109 million people volunteered in 1998, 56% of the adult population. That's the equivalent of over 9 million full-time employees working 19.9 billion hours, at a value of \$225 billion.

This seems like it must be related to another trend I've observed: a career shift to the non-profit sector of individuals who have worked in corporations. For instance, when I attended a statewide conference last fall, I found myself sharing lunch at a banquet table with six other individuals, of whom two were independently attending the conference as a way to find out more about nonprofit careers. They had both worked for a number of years in large corporate settings and had decided it was time to "do something different." Their volunteer activities and interests had led them each to consider working as an employee of a non-profit.

An October article in Parade Magazine confirms that my lunch partners are not alone. The article is specifically about a significant number of corporate executives quitting their jobs to become priests, ministers, or rabbis, but the comments made by some of the individuals in the article are applicable in non-religious situations. They indicate a commitment to serving others and a willingness to forgo financial rewards in return for greater satisfaction. Another October article, excerpted on an e-mail list called the Philanthropy News Digest, mentions that a new type of startup company is one that is for-profit but which handles certain technical tasks for nonprofits. Former Microsoft business development director Pete Mountanos, founder of the web site <charitableway.com>, explains that these companies are not designed to make the large profits earned by most successful high-tech ventures. Instead, he says, "we think of it as a way to give something back if we can support these charities."

With Board elections approaching (see related material in this newsletter) and many ambitious projects on the horizon, the ARS can always use support from its volunteers. For those who are too busy for Board service, or even to become a member of an ongoing ARS committee, there are shorter-term volunteer activities periodically available. When the Board that will be elected in a few months gathers for its initial meeting in September, one of its first tasks will be to assemble committees, task forces, and liaisons to accomplish its goals. The help, experience, and input of many individuals from the ARS membership, Board members and others alike, will be needed.

Most ARS projects can now be done by "virtual" committees who correspond with each other regularly by e-mail, phone, and fax. Some others, such as Festival events, are best done by those who can actually attend. If you are interested in any type of volunteer activity with the ARS, please contact the ARS office or indicate your interest at the bottom of your next renewal form.

SCHOLARSHIPS AVAILABLE TO ALL RECORDERISTS

Applications for summer scholarships, which cover tuition amounts of \$150-\$300, are now available and should be mailed to the ARS office with a postmark no later than April 15.

ARS scholarships are paid from several memorial funds established by friends and family members of former ARS members: Andrew Acs, a gifted recorderist who shared his talents through his teaching at workshops; Jennifer Wedgwood Lehmann, a long-time member of the Princeton (NJ) ARS chapter; and Margaret S. DeMarsh, director of the Adirondack Baroque Consort. Both Acs and Lehmann also served on the ARS Board of Directors.

Beginning in 1998, Canto Antiguo workshop waived tuition for any ARS scholarship winner who attended that workshop, thus extending the ARS scholarship program's effectiveness. Other workshops may also provide scholarship assistance to deserving and talented applicants; please contact the workshops directly to inquire about such availability.

Applications for weekend scholarships of less than \$125 are always accepted, but are best submitted two months before funding is needed.
