2005 ARS CONFERENCE ANNOUNCED

Plans are underway for the first ARS Conference, to be held **July 28-31, 2005**, at **Regis University in Denver**, **CO**. The conference will focus on two topics: "Recorder Pedagogy: From Classroom to Concert Hall", and "Chapter Leadership."

Daily events will include pedagogy classes, lectures, demonstrations, master classes, recitals, panel discussions, coached and informal playing sessions as well as opportunities to take private lessons with conference faculty members. Faculty will include Eva Legêne, Matthias Maute, John Tyson, Mark Davenport, Frances Blaker, Tish Berlin, Cléa Galhano and Ken Andresen.

The conference will coincide with the grand opening and dedication of the Recorder Music Center, a new repository for recorder music and related items at Regis University.

ARS APPEALS ARE FLYING HIGH

ARS members and friends have given generously to the two special fund appeals initiated this past spring. The Erich Katz Fund and the David Goldstein Fund appeals were authorized by the Board of Directors in 2004, and are well on their way to providing the funding needed for several exciting ARS projects.

The David Goldstein Fund will make possible the publication of previously unpublished recorder works by the late composer and by other promising composers and arrangers. The Goldstein Fund is off to a great start, with gifts of more than \$3,500 received and more arriving at the ARS office every week.

Members' Library Editions, published by the ARS and distributed to its members free of charge, are among the most popular membership benefits that the ARS provides. The Members' Library has been supported since its inception in the 1980s by the Erich Katz Fund. The Katz Fund was established in the early 1970s to honor the memory of the eminent teacher, composer, arranger and leader in the American recorder movement. There have been 27 Members' Library Editions since Jennifer W. Lehmann's arrangement, "Elizabethan Delights," was first published in 1987.

Response to the 2004 Katz Fund appeal, meant to bolster the funds needed to continue publishing the *Members' Library* Editions, has been very strong, with nearly \$3,000 in contributions received since June.

THE ARS PERSONAL STUDY PROGRAM

If you are seeking to improve your playing skills through lessons or self-study, three helpful education publications are available from the ARS office: the *Guidebook to the ARS Personal Study Program* (1996 edition), *ARS Personal Study Program in Thirteen Stages*, and *ARS Music Lists*.

The *Guidebook* includes goals and requirements for three levels of playing proficiency (advanced beginner, intermediate, and advanced) in four areas (technique and theory, ear training, sight-reading, and repertoire). An optional exam is associated with each of those levels, and the *Guidebook* is designed to help members prepare for those exams—but it is also useful for self-improvement without reference to the exams.

The *Thirteen Stages* is a checklist to be used in conjunction with the *Guidebook*. Every new ARS member receives a free copy, and replacement copies can be purchased from the ARS office. This publication can be used to determine when a member is ready to take one of the level exams and can also help you to place yourself in playing groups and workshop classes.

Repertoire played during the exams is chosen from the *ARS Music Lists*. The 2002 *Revision* and 2003 *Supplement* are currently available from the ARS office, but older versions may be used as well if you or your teacher has them. And, of course, members can also use the repertoire in the *Music Lists* for personal enjoyment without taking the exams. The annotations give information that can be useful when purchasing music of an appropriate level.

All of the above-mentioned publications can be ordered from the ARS office. Prices are listed in every issue of *American Recorder* on the "ARS Publications" page.

ARS SCHOLARSHIPS AWARDED FOR 2004 WORKSHOPS

Five individuals, representing diverse geographical areas, received ARS scholarships in 2004.

Because of the relatively small number of applicants this year, it was possible to award two President's Scholarships. The recipients were **Heather Seefeldt** of Idaho Falls, ID, who attended the San Francisco Early Music Society (SFEMS) Recorder Workshop, and **Rachel Siegel** of Manchester, MO, who attended the Amherst Workshop.

Heather, age 15, is a recorder student of Dr. David Gonzol, Music Education Coordinator at Idaho State University, and has previously studied in New Zealand and attended the Colorado and Indiana Recorder Academies for young players. She belongs to a seven-member recorder ensemble and has performed frequently at Sunday worship services as a soloist or with her group. In addition to recorder, she plays flute, piano, acoustic, guitar and electric bass.

For the past four years, Rachel, also age 15, has been an active member of the St. Louis Recorder Society, an ARS chapter. She has participated in chapter workshops and played at madrigal dinners and Shakespeare festivals with other members of the chapter. She currently studies recorder with Rob Turner at Indiana University and has previously attended the Indiana Recorder Academy with an ARS scholarship. In addition to recorder, she plays clarinet.

Also receiving summer workshop scholarships were **Rebecca Molinari** of Albany, CA, who attended the Oberlin Baroque Performance Institute, and **Samantha Redston** of Berkeley Springs, WV, who attended the Mideast Workshop.

A serious student of both recorder and oboe, Rebecca, age 16, is a former East Bay Junior Recorder Society member. Currently a recorder student of Hanneke van Proosdij, Rebecca has also studied with Louise Carslake and other Bay area teachers, has participated in numerous local workshops, has performed frequently in school and chapter concerts, and has taught young children at the SFEMS Discovery Workshop. She attended the SFEMS Baroque Workshop in 2003 with an ARS scholarship.

Samantha, a self-employed massage therapist, has been playing recorder in various ensembles for more than 30 years and has recently started teaching beginning students. Her present recorder trio, which she founded four years ago, is the only early music group in the Eastern Panhandle of West Virginia.

One weekend workshop scholarship was awarded this year to **Becky Friddell** of Kent, WA, to attend the Seattle Early Music Guild's "Dancing Master" Workshop held in February. Although Becky has played recorder for only two and a half years, she is a member of three different consorts in addition to a folk ensemble that has performed in the Seattle area and recorded a successful CD. She enjoys sharing her love of the recorder and early music with others and hopes to start a recorder consort at a local elementary school or high school.

ARS summer scholarships are paid from memorial funds established by friends and family members of former ARS members Andrew Acs, Jennifer Wedgwood Lehmann, and Margaret S. DeMarsh. Additional funds for this year's awards came from a scholarship fund-raising drive launched in the spring of 2003.

ARS scholarships are available to players of all ages and ability levels. Applicants should show a serious interest in the recorder and enjoy sharing their love of the instrument with others.

Applications for weekend scholarships of less than \$125 are always accepted, but are best submitted at least two months before funding is needed. Applications for summer scholarships are due each year in early April. These awards usually cover tuition amounts of \$150-\$300.
