PREPARATIONS UNDER WAY FOR 2006 ARS BOARD ELECTIONS

The ARS Board of Directors has selected the following individuals to serve on the Nominating Task Force (NTF) for 2006 Board elections: **Janice Williams**, chair, Birmingham, AL; **Kathryn Cochran**, San Leandro, CA; **Nikolaus von Huene**, Brookline, MA; **Lia Starer Levin**, Los Angeles, CA; **Amanda Pond**, Milford, CT; **John Nelson**, Chamblee, GA; and **Charlotte Trautwein**, Sarasota, FL. Current Board member Amanda Pond will act as a liaison between the group and the Board. She and chair Janice Williams will serve as primary contacts between the NTF and the ARS membership.

The ARS *By-Laws* specify two ways of becoming a candidate for the ARS Board. The first is through the nomination process conducted by the NTF. All ARS members in good standing are asked to participate in the election process now by suggesting to the NTF any individuals who possess the background and knowledge necessary to serve effectively on the ARS Board of Directors.

As suggestions are made, the NTF may interview proposed candidates by telephone. All individuals who have been proposed or who have asked to be considered for nomination will receive information about ARS Board service and a biography form to return to the NTF chair no later than **October 15.** The nomination and biography form must be mailed or e-mailed; receiving faxed materials is not possible.

After receiving forms from those willing to be considered for the Board, the NTF will choose a preliminary slate of candidates. Anyone not selected through the nominating process may employ the second method of becoming a candidate for the Board of Directors, which is by submission of a direct petition.

Any ARS member may be placed on the election ballot by sending the following to the chair of the task force: 1) a petition signed by at least 25 members of the Society; 2) a statement of the nominee's qualifications for the post of Director; 3) a statement, signed by the nominee, expressing willingness to assume the responsibilities of a Director and to serve as a Director if elected.

Those wishing to become a candidate using the petition method will be sent the necessary materials in December following the task force's choice of the preliminary slate. All petition materials are due back to the NTF chair by **January 6, 2006,** in order to appear on the ballot, which will be mailed with the March 2006 issue of *AR*.

Some of the important skills needed for prospective Board members are development/fund-raising, marketing, press relations/ publicity, financial management/accounting, education, nonprofit management, foundation/corporation expertise or legal background. Other important factors not related to experience include diversity of all types and a commitment to raise money to further the mission of the ARS.

TALES OF SCHOLARSHIP RECIPIENTS, CHAPTER II: WHERE ARE THEY NOW?

Letitia Berlin, fondly known as "Tish," may be one of the few outstanding recorder players today who did not turn to the instrument seriously at an early age. Even though she had been playing the recorder for fun as early as age 12, she was a piano performance major in college, receiving a B.M. in that area. Only during her years at the University of North Carolina at Greensboro did she take up the recorder seriously, playing in the collegium taught by Carol Marsh.

Tish was awarded an ARS scholarship after she began studying for an M.A. at Case-Western Reserve University. Her major by that time was early music performance practice, and recorder was her principal instrument. She attended both the San Francisco Early Music Society Baroque Workshop and the Amherst Virtuoso Recorder program (she couldn't remember for which one she used the scholarship). She feels that both workshops were particularly valuable. Her teacher at both workshops was Marian Verbruggen, and she met Frances Blaker at the SFEMS workshop. Frances and Tish have been partners in life and work since 1991.

Berlin received a Master of Arts in early music performance practice in 1992. She and Frances moved to Atlanta that summer and established teaching studios. At the same time, they formed an ensemble with 'cellist and gambist Martha Bishop and organist Rip Jackson. The two also took turns serving as music directors for the Atlanta Recorder Society.

After five years of successful studio and playing opportunities in the Atlanta area, Tish and Frances decided to move to the Berkeley area, where there is a long-established early music scene. Atlanta's early music activities were growing at that time, but the area was not yet able to fully support two free-lance recorder players. Since that move in 1997, Tish has used Albany, CA, as her base for frequent travels to teach at workshops and play concerts. She and Frances are half of the Farallon Recorder Quartet, and the two of them play with other groups around the country. They also play as a duo under the name Tibia Recorder Duo.

In addition to her other labors, Tish is an ARS Board member and is especially involved with the educational component of the Board's work. —John Nelson
