ON THE ROAD AGAIN

ARS was represented at the American Orff Schulwerk Association (AOSA) national conference by Kathy Sherrick, Administrative Director; Tish Berlin, President; and three board members: Alan Karass, Bonnie Kelly and Leslie Timmons. The conference, entitled "The Art of Play," took place in San Jose, CA, from November 14-17. Sherrick and Karass manned the ARS booth at the exhibits, while the others attended conference sessions, both recorder-related and other.

Recorders were in evidence even from the opening session, when children played the "Linus and Lucy" theme. Martha Crowell's session, "Beginning Recorder Adventures in Flight," centered on bird calls (both sung and reproduced on recorders) and other avian-related music. She also led an Orff-Schulwerk Level One teacher training session. Matt McCoy presented innovative ideas for teaching children in "Recorder Right from the Start": layering ostinati as warm-ups, making tongue-twisters into tonguing technique, teaching a song by introducing a single measure, and "evolving the melody by making simple changes."

Former ARS Board member and recorder professional **Cléa Galhano** was a featured presenter at the conference. She started by leading a well-attended late-night recorder reading session. Galhano also performed a noontime concert entitled "The Art of Play: Invention, Fantasy, Joy and Humor in Music" to a standing-room-only crowd. She followed that with a two-session master class where she stressed "the importance of having a concept of the sound" and, as always, the art of articulation.

Following on the theme, an entire session by Galhano was devoted to "The Art of Articulation" and another to "The Art of Play," in which she encouraged local children to "tell a story" with each song.

The **East Bay (CA) Junior Recorder Society** presented a concert of music ranging from *Ghost Play* (in which the children created ghostly effects by using recorder headjoints and blowing across fingerholes) to more traditional consort music, and Chinese and Hebrew folk songs.

The joint ARS/AOSA committee met on November 17. Chair **Martha Crowell** introduced ARS Board members in attendance (Kelly, Karass and Timmons), and then announced that Timmons will chair the committee starting with the 2008 AOSA conference.

The committee reflected on recorder offerings at the San Jose conference, noting that Galhano is unique in her ability to offer both excellent recorder performance and a teaching style that is accessible for Orff teachers. Presenters for future conferences should plan to follow the required application procedure for all AOSA conference sessions. Applications for the 2009 conference (in Milwaukee, WI) will be available on the AOSA web site in February and must be submitted online by August 1, 2008.

The committee discussed and refined its mission . Articles for the "Recorder Corner" in the AOSA's *Reverberations* were mentioned. The possibility of an exchange of previously published articles is being explored. Topics of particular interest include classroom instruction, selecting and testing good quality plastic instruments, and adaptive instruments for students with special needs.

JUDITH LINSENBERG RECEIVES ARS PROFESSIONAL DEVELOPMENT GRANT

Judy Linsenberg is the 2008 recipient of the ARS Professional Development Grant. The grant was established to help professional recorder players carry out special projects that will further their careers and development as recorder players. Its primary purpose is to provide financial help to the recorder player awarded the Oregon Coast Recorder Society's Recorder Residency at the Sitka Center for Art and Ecology in Otis, OR.

Linsenberg's projects during her residency include: studying and arranging Bach's unaccompanied 'cello and violin pieces for recorder and preparing them for performance and recording; preparing a school/outreach program that could be adapted for different ages and that would demonstrate various aspects of the recorder and its literature; and working with Cléa Galhano to prepare a duo program and workshop.

Application deadline for the recipient of the 2009 Sitka Recorder Residency is September 15, 2008. All other proposals may be made at any time. For more information contact the ARS office. Guidelines for the Professional Development Grant will soon be posted on the ARS web site.

The full ballot containing each candidate's biography and personal statement, plus more details about voting, will be mailed in the *ARS Newsletter* with the March *AR*.

According to the *ARS By-Laws*, at least 10 Board members must be elected and no more than five additional members may be appointed. Five of the current elected Board members will complete their terms in 2008. Their successors will be determined by the upcoming election.

The NTF is charged with selecting candidates who represent diverse aspects of the recorder community. Suggestions for potential Board members were solicited from ARS members throughout North America. All ARS members in good standing were asked to participate in the election process by suggesting to the NTF any individuals who possess the background and knowledge necessary to serve effectively on the ARS Board.

UPDATE ON THE ARS PERSONAL STUDY PROGRAM

The ARS Education Committee is in the process of revising the ARS **Personal Study Program** (PSP) to reflect that it is now a self-study resource that will be available online as a benefit to ARS members. The goal is to place its components online in three installments over the next 18 months.

As of April 1, 2007, the ARS stopped administering the PSP achievement exams (or playing proficiency exams), except for teachers and students who started the process of preparing for exams prior to that date. Those individuals have until **December 31, 2010,** to complete the exams.

The committee will continue to update the PSP *Music Lists* every three years. Questions about the PSP may be directed to the ARS office.

IN MEMORIAM

Cagin, Harry, Pepper Pike, OH. Died October 9, 2007, age 92. One of the seven founding members of the Greater Cleveland ARS Chapter. An engineer by profession, and president and CEO of Halex Corporation; was the national president of the Society of Die Cast Engineers. He was a contributor to numerous local civic and arts organizations, strongly supported the Cleveland-area Jewish community, and was a member of the American Civil Liberties Union. He served as chapter treasurer from 1967 to 1975, and hosted the annual June picnics from 1972 to 2002. He was a generous donor to ARS annual fund drives for many years and continued donating long after illness prevented him from playing the recorder.

Clements, Walter, Detroit, MI. Died December 1, 2006. A member of the ARS since 1995, and a member of the Detroit chapter.

Comstock, Dr. George, Smithsburg, MD. Died April 15, 2007, age 92. A nationally renowned epidemiologist and leading authority on tuberculosis. Founded the Johns Hopkins Training Center for Public Health Research and Prevention in Hagerstown, MD, in 1962. He formed his first recorder quartet at age 15 in Niagara Falls. He founded two early music ensembles while on faculty at Johns Hopkins: The Elizabeth Towne Consort and the Washington County (MD) Museum Recorder Consort. He remained in the Museum Consort from 1979 until 2004 and continued to play in the Elizabeth Towne group until shortly before his death. In addition to recorders, he played many other early woodwinds including krummhorn, cornemuse, kortholt, dulcian, Renaissance flute, penny whistle, and traverso, plus the mandolin. He was a member of the ARS for at least 30 years and a generous supporter of the ARS President's Appeal and Spring Fund Drives.

Gilman, Lois Nadine, Colorado Springs, CO. Died January 27, 2007, of lung cancer. Nadine was active in the Colorado Springs Recorder Society, serving as its president. A member of the ARS since 2005.

Haglund, Carolla, Brunswick, ME. Died August 12, 2007. Carolla began her career in the insurance industry and later became a school teacher. She served as the Dean of Women at Framingham State College. Carolla had many artistic hobbies, sang and played the trumpet in addition to the recorder. Carolla joined the ARS in 1960.

Kelly, Michael, Wingdale, NY. Died December 26, 2006, after a long illness. Husband of Tricia Van Oers.

Mayti, Marion, Orange, OH. Died March 2, 2007, age 89. Marion taught in the Orange school system for 22 years and played the viola. She was a founding member of the Cleveland Women's Orchestra in 1935 and played in it for 69 years. She also played in the Suburban Symphony and Shaker Heights and Chagrin Falls symphony orchestras. Marion joined the ARS in 1982 and was strongly involved in the Cleveland Chapter in the 1980s and '90s along with her husband, Steve.

Reichenthal, Cynthia, East Northport, NY. Died November 2007. Wife of Eugene Reichenthal. Cynthia was Gene's support through the years he ran the one-day children's workshop and the week-long summer workshops on Long Island. Without Cynthia's tireless efforts, the workshops would have been impossible.

Sacksteder, Richard, New York, NY. Died November 4, 2007. Husband of Martha Bixler. Dick was a well-known mathematician and taught most recently at the CUNY Graduate Center in the Ph.D. program. He faithfully supported Martha in all her music interests, including going to performances and "schlepping" instruments and music stands. Dick helped assemble and provide photos for Martha's memoir of the ARS. A member of the ARS since 1955 and a generous donor.

Tarail, Mary, Laguna Woods, CA. Died August 18, 2007, from complications of Parkinson's disease. Mary was a long-time member of the Orange County Recorder Society and joined the ARS in 1986.

Wenzel, Dominique, Princeton, NJ. Died October 10, 2007, age 59, as a result of a bicycle accident. Dominique was born in Melle, France, and attended the University of Poiters and the Sorbonne in Paris. She studied at the University of Chicago under a Fulbright Fellowship, where she met her husband. She lived in France, Denmark, England and Maryland before moving to Princeton in 1987. Dominique was a well-loved French teacher in the Princeton area and co-authored several French language books. She was active with the Princeton Recorder Society (PRS) as an officer and a player. The PRS Performing Ensemble, of which Dominique was a member, played at her celebration of life on Saturday, October 20, 2007. Dominique was a member of the ARS since 1993.
